Section A: JOINTLY DEVELOPED

General Philip Kearny Elementary School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- *Parent and Family Engagement Policy and School-Parent Compact are distributed via multiple methods in the fall of each year.*
- *Parent activities are held at various times during the day to increase parent participation and meet schedule needs.*

*Kindergarten registration will be advertised by hosting a kindergarten open house for parents and prospective students. Each parent and their child(ren) will be invited to visit the kindergarten classrooms and learn about the program. A checklist of expectations is given to parents.
Kearny will set up a Parent Resource Table available to parents.
Pennsylvania Arts in Education Program runs programming for students in grades 5-8.
Representatives from Bethanna come to the school to give parent workshops periodically and provide additional parent resource information.
The District's Office of Family & Community Engagement supports Kearny school in engaging families and providing them with opportunities to increase their ability to support their children.*

Staff at Kearny participate in a PD around working effectively with parents during a District PD date in the Fall or Winter. The PD is informed by feedback collected from parents themselves via surveys.
